QUENIBOROUGH NEIGHBOURHOOD PLAN - PRE-EXAMINATION CONSULTATION

Queniborough Parish Council, through the Neighbourhood Plan Steering Group, has prepared a Neighbourhood Plan for the parish. In accordance with the Neighbourhood Planning (General) Regulations 2012 (as amended) the Rothley Neighbourhood Plan and supporting documents have been submitted to Charnwood Borough Council for the purpose of consultation, examination and, if appropriate, a referendum ahead of it being 'made' (adopted) as part of the local plan for the area.

Charnwood Borough Council has considered the Plan against the statutory requirements set out in paragraph 6 of Schedule 4B of the Town and Country Planning Act 1990 (as amended) and is satisfied that these have been met and it can proceed to consultation.

Due to the recent Covid-19 pandemic we are intending for the consultation to run over an extended period of 10 weeks to account for any disruption caused. The consultation will run from **Monday 3rd August to Monday 12th October 2020**.

There continues to be restricted access to the Council offices and with social distancing measures in place we will not be able to provide hard copies of the consultation documents at viewing points. All of the submission documents are however available to view on our website.
